To the best of our knowledge and based on the composition of the glass nonwovens and based on the currently available information in the safety data sheets of its raw materials, and although we have not performed specific tests, we hereby confirm that polybrominated biphenyls (PBB), polybrominated diphenyl ethers (PBDE), tris(2-chloroethyl) phosphate (TCEP) have not been intentionally added and we do not expect them to be present in the glass nonwovens above the threshold concentration of 0.1%.
